Abstract: The purpose of this study was to determine if there were differences in the prevalence of dental caries between children who had been exposed to fluoride varnish and those who had not. A total of 60 children from two different day care centers were included in the study. All children were given a fluoride varnish treatment at the beginning of the study. After six months, the children were divided into two groups based on their exposure to fluoride varnish. The first group consisted of 30 children who had received the fluoride varnish treatment, and the second group consisted of 30 children who had not received the treatment. The children were then examined by a dentist to determine the prevalence of dental caries. The results of the study showed that the prevalence of dental caries was significantly lower in the group that had received the fluoride varnish treatment compared to the group that had not received the treatment.
